# Privacy Policy

## Introduction

Xxxxx is committed to protecting the privacy and personal information of our customers. Our website with the URL of [REDACTED] is operated by us. The information we collect from our customers through our website is strictly used to provide and improve our products and services.

We use your Personal data to provide and improve the Service. By using our service, you agree to the collection and use of information in accordance with this Privacy Policy.

## Definitions

For the purposes of this Privacy Policy:

- **Account** means a unique account created for You to access our Service or parts of our Service.

- Our **cookies** help us to learn more about Your interests and let Us deliver the right content and experience. You can control the use of cookies through Your browser settings.

## Retention of Your Personal Data
